Dr Vikki Hunkin is a HCPC registered Clinical Psychologist and Clinical Neuropsychologist. She has worked in Clinical Neuropsychology for many years, both in NHS Clinical Neuropsychology services and in independent and medicolegal practice. Her expertise in cognitive and neuropsychological assessment is wide-ranging and comprehensive.

AREAS OF EXPERTISE

Dr Hunkin has specialist training in cognitive and neuropsychological assessment of adults. She holds the Qualification in Clinical Neuropsychology (QiCN). This is the British Psychological Society's "gold-standard" qualification in cognitive and neuropsychological assessment.

Dr Hunkin has extensive experience working with patients across neurology care pathways, from acute inpatient wards to community settings. The focus of her work is cognitive assessment to diagnose problems with memory, language, attention and other cognitive skills; and treating these problems using the best evidence-based psychological rehabilitation approaches.

She is experienced in assessing a wide range of clinical problems, including learning/developmental disability, traumatic and acquired brain injury, stroke, dementia, chronic neurological illness such as epilepsy, and psychiatric conditions which present with cognitive problems.

EXPERIENCE

Dr Hunkin has provided medicolegal reports to the courts since 2017. She completes around 50 reports each year, including cognitive assessments, mental capacity assessments and full neuropsychological assessments.

<u>Cognitive Assessment</u>, to assess memory, language, attention and other cognitive skills, and give an over IQ score.

<u>Mental Capacity Assessment</u>, including litigation capacity, testamentary capacity, capacity to make care decisions, financial capacity, and fitness to plead and stand trial.

<u>Neuropsychological Assessment</u>: to assess the impact of neurological injury or illness on cognition, emotional well-being, and behaviour; give an opinion on severity of injury and prognosis; and provide expert guidance on the management and treatment of neuropsychological problems

Dr Hunkin has experience of giving evidence in court and in producing joint statements. She has completed Bond Solon training in expert witness skills.
