She has built upon knowledge and application of cognitive-behavioural, cognitive-analytical, narrative, systemic, psychodynamic and psychoanalytical approaches in clinical work by attending courses and seminars, and through peer, group and individual supervision.

With a vast experience of working with a broad spectrum of psychological difficulties necessitating the provision of both short-term and longer-term psychological services to adults with mental health problems. Presenting difficulties dealt with have included childhood sexual abuse, bereavement, depression, eating disorders, anxiety, phobias, OCD, PTSD and psychoses. She has an interest in working with people with psychological problems arising from issues related to personality, cognitive functioning, physical health, trauma, loss, cultural uprootment, gender and cultural identity.
