Dr Stephanie Wilson is an HCPC Registered Forensic Psychologist and Chartered Psychologist and an Assistant Professor specialising in areas fundamental to family and criminal law. Her work spans clinical practice and academia, focusing on:

- Childhood adversity and its effects, such as neglect, abuse, and exposure to violence
- Adaptation to threatening environments and abuse,
- Comprehensive assessments of cognitive functioning, attachment, personality, and psychopathology
- Risk assessment of violence, harmful behaviours, child abuse, and neglect
- Therapeutic needs of high-risk adolescents, adults, and families.

Clinically, Dr Wilson aids professionals in understanding individuals with complex psychological profiles and risk behaviours, conducting cognitive and psychological assessments, and evaluating risk. She provides consultation to parents, foster carers, residential care staff, and professionals to address the needs of adolescents and adults.

She has designed and delivered therapies for diverse populations, including adolescents in or at the edge of care, adults in care proceedings, and those in forensic mental health and prison settings. As Lead Therapist in a therapeutic residential service for adolescents, she coordinated therapeutic interventions and provided consultation, training, and supervision.

Academically, Dr Wilson is an Assistant Professor at the University of Birmingham, involved in Europe's only Doctorate in Forensic Clinical Psychology programme. She teaches, supervises, and evaluates trainee forensic clinical psychologists. Dr Wilson also teaches at other universities on professional doctorates and master's programmes, including the University of Nottingham and the University of Bath. Additionally, she delivers training on attachment-based practices to East Sussex County Council practitioners.

## Jul 2019 – Present Curious Psychology Ltd, Registered Forensic Psychologist

Working as a Forensic Psychologist in a psychology practice with clinical and forensic emphases. Clinical responsibilities include:

- Assessing parents' cognitive functioning to establish their ability to understand and engage in proceedings.
- Conducting comprehensive psychological assessments, including the assessment of personality, psychopathology, and risk, for Court Proceedings.
- Writing reports for Court; communicating psychological concepts in a clear and understandable manner.
- Drawing upon psychological theories, devising psychological formulations, and making clear and actionable recommendations.
- Designing and delivering Court-ordered psychological therapies to adults who experienced danger earlier in their lives and are having difficulties in the 'here and now'. For example, individuals who have been involved in Care Proceedings after struggling to adapt to their transition into parenthood, finding themselves in troubling patterns of relationships, or needing to enhance their ability to protect their children.
- Providing consultation and devising therapeutic and risk risk-management plans to support
  adolescents with histories of abuse and neglect who present with complex risks (e.g., of violence,
  harmful sexual behaviour, self-harm, suicidality, and vulnerability to criminal and sexual exploitation).
- Delivering consultation and interventions to help residential care staff and other professionals attune to the psychological, attachment and relational needs of adolescents with complex risks.
- Providing training on attachment-based practice to practitioners in East Sussex County Council as an associate for Independent Social Work Matters.
- Training and supervising a 'Stage Two' British Psychological Society qualification in forensic psychology. Co-ordinating, overseeing, evaluating, and holding clinical responsibility for the trainee's assessment, therapeutic intervention, and risk management work.
- Providing peer supervision to other Registered Clinical and Forensic psychologists who conduct assessments for Court Proceedings and Parole Hearings.



## Apr 2020 - Present Meadows Care Ltd, Lead Therapist & HCPC Registered Forensic Psychologist

Working as a Lead Therapist (Forensic Psychologist) in a specialist therapeutic residential service for adolescents. Clinical responsibilities include:

- Overseeing a caseload of adolescents with histories of danger (e.g., abuse and neglect), complex attachment strategies, trauma, emerging psychopathology, and/or risk behaviours. Co-ordinating all therapeutic aspects of intervention.
- Conducting psychological assessments, including assessment of risk, of adolescents.
- Designing and delivering psychological therapies.
- Providing psychological consultation to care staff to guide 'wrap-around' therapeutic care.
- Providing psychological consultancy to external professionals (Local Authority staff, schools, YOT's and CAMHS staff) to enable them to understand the psychological and relational needs of adolescents.
- Delivering training, supervision, and reflective practice groups to care staff and other professionals.
- Providing clinical supervision to assistant psychologists, assistant therapists, and trainee psychologists.
- Training in child development, trauma, attachment, and therapeutic parenting.

# Oct 2015 – Jul 2019 Wilcox Psychological Associates Ltd, HCPC Registered Forensic Psychologist (formerly a Forensic Psychologist in Training)

Trained and then worked under the supervision Professor Daniel T. Wilcox, Consultant Clinical and Forensic Psychologist, in a psychology service that specialised in assessments for Court proceedings. Clinical responsibilities included:

- Assessing cognitive functioning pre-proceedings.
- Conducting psychological assessments, including the assessment of risk, with parents subject to Court proceedings.
- Assessing personality, interpersonal functioning, and psychopathology.
- Writing clear and accessible reports for Court.
- Delivering psychological therapies to adults subject to Care and Family Proceedings.

- Conducting screening assessments for the service (assessing personality, interpersonal functioning, affect regulation and trauma symptoms).
- Conducting psychological assessments and forensic risk assessments.
- Drawing upon psychological theory to devise psychological formulations of the women's offending behaviours and making treatment recommendations.
- Delivering and co-facilitating group-based psychological interventions (Compassion Focused Therapy targeting trauma symptoms; Trauma Recovery and Empowerment Model; Good Lives Model; Mindfulness and Relaxation).
- Providing psychological information to a multidisciplinary team of Psychologists, Occupational Therapists and Prison Officers, and external professionals.

## Apr - Oct 2016 Ardenleigh Women's Service, BSMHFT, NHS, Forensic Psychologist in Training

Worked under the supervision of Dr Helen Matthews, Clinical Psychologist, in a medium secure, forensic mental health hospital for women. Clinical responsibilities included:

- Co-facilitating a high intensity offence-focused, Cognitive Behavioural Therapy group intervention for women with histories of habitual aggression (Life Minus Violence).
- Delivering individual psychological therapies to women with complex mental health difficulties (Acceptance and Commitment Therapy and Cognitive Behavioural Therapy).

- Administering, scoring and interpreting psychometric measures designed for children and adolescents.
- Drawing upon a range of models for psychological formulation to inform psychological interventions, care plans and behavioural management plans (such as Positive Behavioural Support plans).
- Delivering group-based interventions (CBT-based anger treatment; CBT-based substance misuse relapse prevention; moral reasoning development; and prosocial skills training).



- Co-facilitating a family therapy intervention under the supervision of a Consultant Systemic Psychotherapist.
- Disseminating psychological knowledge to a multidisciplinary team and external professionals (at Care Plan Approach meetings, Looked After Children reviews, clinical review meetings, professionals' meetings, formulation meetings and safeguarding meetings).
