Dr Christopher Hobson is a Consultant Clinical Psychologist with over 13 years post-qualified experience of working clinically with adults, and conducting clinically-relevant research.

He has an undergraduate degree in Psychology from St. Andrews University, a Masters in Forensic Psychology from Kent University, a PhD in Developmental Psychology from the Institute of Psychiatry (Kings College London) and a Doctorate in Clinical Psychology from Royal Holloway University. He is chartered with the British Psychological Society (BPS) and registered with the Health & Care Professions Council (HCPC).

Dr Hobson is the Academic Director for South Wales Doctoral Programme in Clinical Psychology (employed by Cardiff and Vale University Health Board, and based at Cardiff University). Further, he is the Clinical Psychologist for the Neurodevelopmental Assessment (Research) Unit at Cardiff University which conducts research into understanding and intervening in children with emotional and behavioural difficulties and their families (including researching novel parenting interventions). As part of these roles, he is required to be very up-to-date with the main developments across the broad field of Clinical Psychology. Further, he provides teaching and/or conduct research into areas relevant to family court work, including the impact of environment and parenting on children's development, personality and complex trauma, and mental capacity. He has several publications in peer-reviewed journals in the areas of child and parental mental health, and working with complex/traumatised populations.

Since 2012, he has also worked independently, predominantly conducting assessments of parents involved in childcare proceedings or at the pre-proceedings stage. He has also conducted assessments in criminal court cases, for the Parole Board, provided private therapy, as well as professional psychological consultation sessions (e.g., to the National Probation Service Wales).

Prior to Clinical Psychology training in 2007, Dr Hobson had several years of research experience working on clinical trials of parenting programmes. Between 2010 and 2016, he worked with men and women in adult forensic settings (Llanarth Court medium secure hospital, and Eastwood Park women's prison). Within these roles he carried out many comprehensive assessments of risk (using structured professional judgement risk assessment tools for sexual or violence risk, such as the HCR-20 and RSVP), mental health/personality difficulties and cognitive/neuropsychological function.

Across employed roles and hid independent work, he has particularly developed expertise in assessing and treating those who have histories of personality difficulties related to complex trauma and early disrupted attachments, as well as those who have committed violent offences and/or offences against children (including physical and sexual abuse, and neglect). He also has experience with working with a wide range of other difficulties including recurrent anxiety and depression, OCD, psychosis, bipolar disorder, autism, ADHD, cognitive



impairment and brain injury. He is trained in various therapies including Cognitive Behaviour Therapy, Mentalization Based Treatment and EMDR.

Dr Hobson has prepared more than 325 reports mainly for the **family courts (including pre-proceedings assessments), but also for the criminal court, parole board, and mental health review tribunals**. These reports have covered the following areas:

- Assessments of mental health (including substance misuse) in adults
- Cognitive/Capacity issues (e.g., to instruct a solicitor)
- Risk assessment
- Impact of the above on parenting
